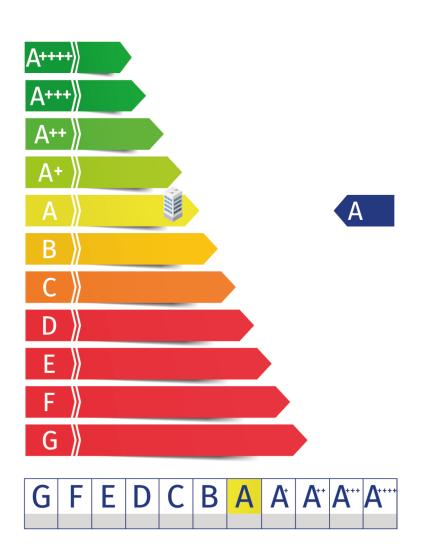

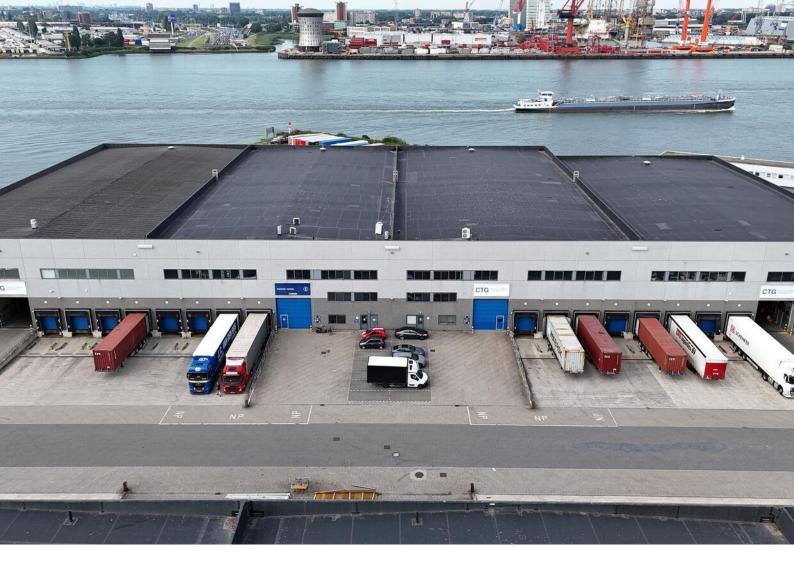

Description

General Information

The central location in the middle of the Rotterdam port area guarantees unique tri-modal accessibility. Distiport Benelux comprises over 28,000 m² of logistics space divided into two buildings. A total of 10 separate units of approximately 2,400 m² each have been created, which can be fully customized thanks to the column-free span of 33.8 meters. The units are suitable for both the storage and distribution of general goods and hazardous materials, and can be interconnected. The necessary (environmental) permits for the storage of hazardous materials and general goods are already in place for the entire project. This saves tenants from complicated procedures and time. Renting today means starting tomorrow!

Directly next to this location is the CTT terminal. The CTT terminal in Rotterdam is easily accessible by

road, rail, and water and is attractively close to high-frequency deep-sea and short-sea connections. From CTT Rotterdam, there are daily inbound and outbound trains from many locations in Poland, and there are rail connections with Antwerp, Switzerland, France, and Spain.

This terminal is accessible for ISPS, sea, and inland vessels up to 200 meters with an 8-meter draft. Furthermore, this terminal has a BRZO license and containers with hazardous materials can be stored in a specially equipped ADR parking area. CTT is now part of the Inland Terminals Group (ITG) with a network of 16 terminals spread across the Netherlands and Belgium.



Continued description

Permitted ADR Classes for Units 5B and 5C Below is an overview of the ADR classes permitted for units 5B and 5C:

ADR 1.3 and 1.4: Only emergency signals up to a maximum of 100kg NEM (Net Explosive Mass), spread over 2 warehouses. So 2x 50kg. In fire safety storage cabinets.

ADR 2: Only UN1950 and UN2037, in fire safety storage cabinets, aerosols with flammable propellant gas are not allowed.

ADR 5.1: Yes (limited, details see permit)

ADR 5.2: Yes, up to 1000kg per warehouse and only LQ. Only substances without temperature control. ADR 6.1: Possible, but very toxic substances LT3 and LT 4 are not allowed (details of other restrictions in the permit, such as maximum packaging content).

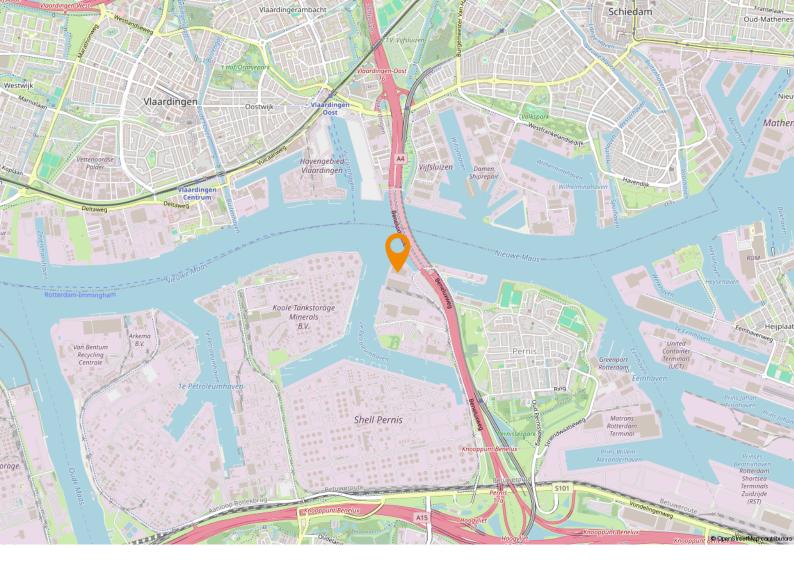

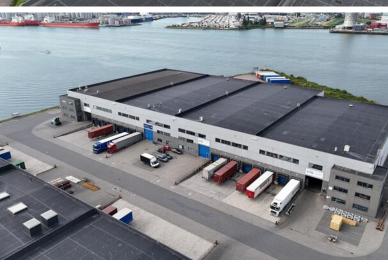














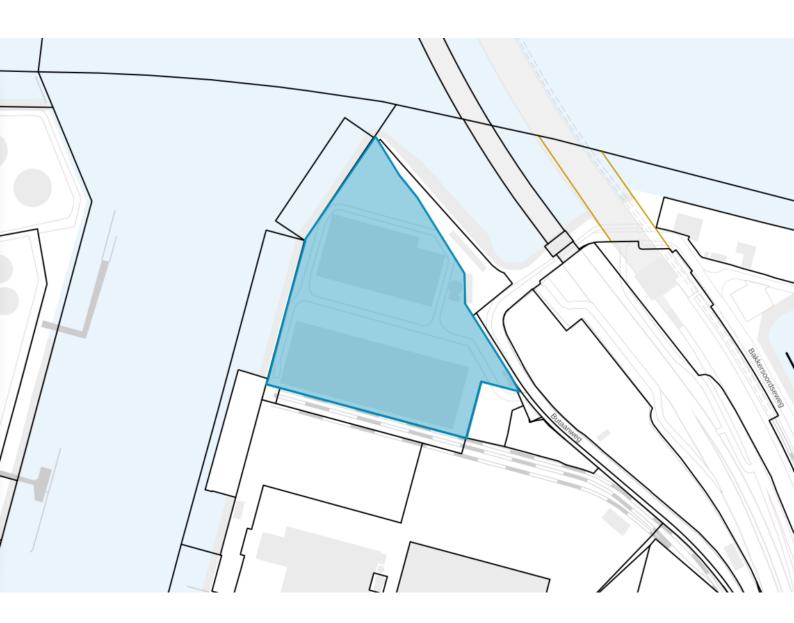








Cadastral map

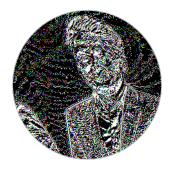

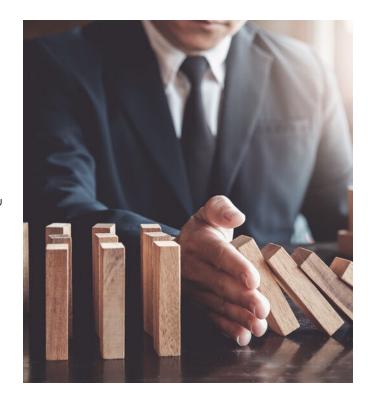
